WOA Urges New USTR to End Barriers to Trade in Wine



On March 17, 2021, the U.S. Senate unanimously confirmed Katherine Tai to be the next U.S. Trade Representative. The Wine Origins Alliance sent Ambassador Tai a letter urging her to work alongside partners in the European Commission to build upon the recent progress that has been made towards resolving the aircraft subsidies dispute and seek multilateral solutions to other disputes that avoid tariffs on unrelated products such as wine, and to better protect wine place names in U.S. trade agreements. This letter followed an agreement among the United States, European Union, and United Kingdom to suspend the Airbus-Boeing retaliatory tariffs for four months. Click here for more details.

Australian Wine Industry Assesses Bushfire Damage, Recovery



After more than five months of ranging bushfires across the continent of Australia, there are few official figures on the wine industry value that was lost because vintners must see how vines recover both from the fires and the searing heat over the next year. <u>Wine Spectator</u> reported that while historically unprecedented, the fires have not presented as large of a loss as initially feared. Recovery, not loss, is a common theme among wine producers affected by the burning and smoke taint.

Texas Wine Growers Agree to Elevate AVA Labeling Requirements



On March 10, several leading associations and players in the Texas wine industry agreed on a legislative compromise regarding the amounts of Texas fruit to be used in Texas wines, allowing the state to join other leading wine producing states and label wines whose fruit comes from designated locations within the state. The legislative compromise language states that "[w]hen using the AVA designation on a wine label, 85% of the grapes in that bottle must come from the AVA stated, while the remaining 15% of the grapes must come from Texas.
